Electronic Visit Verification (EVV):

Medicaid money funds IHSS, this is being used without built in checks and balances, but there are rules for how the money is used. EVV is an effort to account for the time by the providers. There is a financial cost to the state if they do not implement. However, at this time there is at least a one-year delay.

Discussion on Purpose of AC:

There was a lengthy discussion of the purpose of the AC. Past, present and future goals. Committee members spoke to the focus of the committee in recent years has become more on the structure of the PA rather than on client concerns. Committee members spoke to the way they were oriented to the purpose of the committee did not align or match with the actual reality of what was discussed during committee meetings.
