- **EVV (Electronic Visit Verification):** Action of Federal Government require verification. Timesheet System to move everyone into electronic timesheets
- **Sick Leave Pilot County Update:** Union successful in advocating for sick leave. Public Authority pilot project of collecting data for the past 7 months resulting in only 1 call in Jan 2019 regarding the need of a back-up provider due to provider being out sick
- \$12.50 to \$13.85. Then, in January 2020 and additional \$0.40 per hour wage increase for a total of \$14.25

PA Update:

- **Provider Hourly Wage:** Verbal confirmation of wage increase for providers to \$13.85 as of 3/1/2019.
- **Staff:** Calls slowed in December, but picked up in January. Registry providers checking in monthly to aid in keeping registry lists updated. When providers are not checking in, a letter is generated to remind them to check in. Currently 732 providers on registry.
- **Training:** Focused on central region. ~~Currently 1000 participants for trainings~~ Trained 1000 participants over the past year.
